**ORDER:**

The Government of Andhra Pradesh is implementing new version of e-Procurement system vide ref. 1<sup>st</sup> read above for all User Departments and PSUs of Andhra Pradesh since 9<sup>th</sup> May, 2016 with online EMD payment/refund facility to the participating suppliers / contractors. The features of the facility are given below.

- a) In the new version of procurement, the bidders can pay the EMDs using Net banking/RTGS/NEFT, the bidders should pay EMDs from their registered bank accounts and the unsuccessful bidders EMDs will be refunded to their registered bank accounts in the new eProcurement system.
  - b) Also the bidders can pay the EMDs using Credit Card / Debit Card, as per the VISA/Master Card Guidelines, return of EMD will be only to the Originating Card from which payment was made, as per the standard practice of Credit Card / Debit Card refunds.
2. Vide ref. 2<sup>nd</sup> read above, the Executive Officer, TTD requested the EMD amount paid by the successful bidder to be credited to TTD accounts.
  3. The Government after careful examination hereby issues orders to transfer the successful bidders EMD to the user departments registered bank accounts in the new version of eProcurement system.
  4. This order comes into force immediately and is applicable to all user departments/PSUs/Local bodies using the new version of eProcurement platform of Government of Andhra Pradesh.
