ORDER:

Government, vide reference 4th read above, issued orders for Constitution of Consultative Committee on IT Industry (CCITI) for consideration of various incentives to IT/ITES/Electronics/Start-up companies.

2. Vide reference 5th, 6th & 7th read above, implementation and operational guidelines were issued for notification of DESIGNATED TECHNOLOGY PARKs (DTPs) and for processing of incentives/claims for DTP Operators/Lessors and for IT Companies/Lessees by the ITE&C Department.

3. Subsequently, Government recognized the need to issue revised orders by including processing of incentives/claims for Designated Technology Park (DTP) Scheme Operators / Lessors and IT companies / Lessees to the terms of reference of CCITI.

4. Government after careful examination, hereby issues an amendment to the Para (6) of the G.O.Ms.No.18., &ITE&C Department, DT: 16.09.2014, duly adding the following to the terms of reference of CCITI:

“under the DTP Scheme, The Consultative Committee on IT Industry (CCITI) of this Department, constituted as per IT Policy, shall meet periodically to consider the Reports of Inspection Committee and may either recommend or reject the claim/benefit/incentives applied by DTP Operator/Lessor or IT Company/Lessee, basing on the merits of each and every case, which shall be final and binding.”

5. The above orders come in to force with immediate effect.
