ORDER:

Government has issued Innovation and Start-Up policy through GOs vide read 1<sup>st</sup> and 2<sup>nd</sup> shown above. On review and careful consideration of the existing status of the Innovation and start-up ecosystem the Government have laid down the following targets for itself in the area of Innovation and start-up ecosystem.

- 100 Incubators/Accelerators to be established.
- 5,000 Companies and Start-ups to be incubated.
- 1 Million SFT of incubation space to be developed.
- Venture capital of Rs.1000 Cr to be mobilized for innovation.
- Foster Innovation culture.
- Create at least one home grown billion dollar technology start-up.

2. In order to achieve the above targets, Government after careful consideration includes all state run universities, private universities and technical institutions also in Andhra Pradesh innovation and start-up policy issued vide G.O.Ms.No:17 dated 09.09.2014.

3. Further taking into consideration the feed back of Innovation and Start-up industry on the said policy 2014-2020, and in continuation of the orders read above, Government hereby issues the following operational guidelines and application proforma for transparent administration of various fiscal and non-fiscal incentives pronounced in the policy.

- a) Procedure to avail facilities specified in the G.O.Ms.No:17 dated 09.09.2014.
- b) University / Incubator / Technical Institution shall submit the filled in application to AP Innovation society in the prescribed format (**Annexure – I** along with detailed project report giving all details of Incubation space available, number of start-ups ready, number of mentors available and their experience in Innovation and start-up space, Technical facilities available such as Computers, networking, connectivity, power including backup and alternate power, amenities etc.
- c) A separate Committee will be formed for forming detailed guidelines for scrutinizing the proposals from universities and payment of funds and subsequent monitoring. The committee shall submit its proposals to the Government for its consideration. The committee shall comprise of eminent academicians / administrators / professionals from IT industry / representatives from government.
- d) The state run universities and technical institutions shall be given full funding pertaining to infrastructure and running of the incubator. Private universities and technical institutions can be given “matching funding” support. Following support may be extended to the incubators in universities and technical institutions:

1	Infrastructure (computers, networking, hardware, software)	Full Funding	50% funding
2	Expenses related to resource persons (incubation centre manager, technical support)	75% funding – Innovation Society, ITE&C Department 25% funding – Institution	50% funding
3	Mentorship support	Through centralized system of mentorship on payment basis to be shared in the ratio of 75% (Innovation Society) and 25% (Institution)	Through centralized system of mentorship on payment basis to be shared in the ratio of 75% (Innovation Society) and 25% (Institution)
4	Seed funding / Venture funding for the incubatees	Through State Startup Innovation Fund (SSIF)	Through State Startup Innovation Fund (SSIF)
