ORDER

The Government of Andhra Pradesh has initiated the 'MeeSeva' Project to improve public services delivery to the citizen through a well defined architecture and protocol. The Director, Electronic Services Delivery (MeeSeva) [ESD-MeeSeva] was authorized to deliver the citizen-oriented e-services. These services are classified into two categories: Category - A, delivered across the counter and Category- B, undergoing a work flow by the department official concerned following Statutory processes/Notices/Hearings/FieldInspections etc.

2. In the G.O 1streadabove, Government has been permitted the VLEs to charge for scanning of Rs.2/- per page for uploading documents beyond 4 pages, as scanning for upto four pages is free in AP.

3. Vide Minutes of the meeting2ndread above, the Meeseva operators Association has requested to hike the charges from Rs. 2/- to Rs.5/-.Accordingly, vide efile 3rd read above, the Director, ESD(MeeSeva) has requested to hike the charges from Rs.2/- to Rs.5/-.

4. Government after careful examination of the proposal, hereby permits the MeeSeva centers to collect an amount upto Rs.5/- per page for scanning and uploading documents, beyond 4 pages. The charges collected towards the scanning charges shall be shown in the MeeSeva receipt for the convenience of the citizen.

5. The Director, ESD (MeeSeva), AP shall take necessary action accordingly.

6. The orders shall come into force with immediate effect.
